### EMERGENCY PROCEDURES

24 HOUR ADVICE IN AN EMERGENCY ONLY: 0800 764 766

IF THIS HAPPENS	DO THIS
<b>Tanker/Vehicle Accident</b>	Switch off engine and electrical equipment. Keep people away and warn other traffic. Check for spills and leaks. <b>Call the emergency services: Dial 111</b>
<b>Spill or Leak</b>	<b>Major spills: Call the Fire Department and alert them to the nature of the spill.</b> DO NOT TOUCH spilt material. Wear overalls, chemical-resistant gloves and safety goggles. Prevent further spillage. Contain spill and absorb with sand or other suitable material. Place spillage in a sealable container. Wash down affected area with large amounts of water. Dispose of spill container according to the regulations of the local authority. Prevent spillage from entering drains and waterways.
<b>Fire</b>	<b>Call the Fire Department: Dial 111.</b> Wear protective clothing and breathing apparatus. May release toxic fumes under fire conditions. Extinguish fires with water fog, foam, dry chemical or carbon dioxide. Cool sealed drums with water spray to prevent rupturing. Contain and collect run-off (see <b>Spill or Leak</b> section above). Keep non-involved persons away.

### FIRST AID

<b>If Swallowed:</b>	Call a POISON CENTRE or contact a doctor/physician if you feel unwell. Rinse Mouth. Immediately call a POISON CENTRE (0800 764 766) or doctor/physician. If medical advice is needed, have product container or label at hand.
<b>If in Eyes:</b>	Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do so. Continue rinsing. If eye irritation persists: Get medical advice/attention.
<b>If on Skin:</b>	Wash with plenty of soap and water. If skin irritation or rash occurs: Get medical advice/attention. Wash contaminated clothing before use.
<b>If Inhaled:</b>	Remove to fresh air and keep at rest in a position comfortable for breathing. If ill effects persist, contact doctor or poison

**Storage:** Keep out of reach of children. Store in original container with lid tightly closed in a cool, dry, well-ventilated area out of direct sunlight. Store away from alkalis, oxidizing agents and chemicals readily decomposed by acid, food, fertilizers and seeds. Avoid physical damage to container.

### STORAGE AND SEGREGATION SUMMARY
